

Where a thing was decided that that particular condition is what is decided, that puts that condition itself up for a challenge, and the challenger is the opposite of that decision that was made. Therefore, when it comes time to make that implementation of that which was decided in the will to do, there will be the factor that opposes.

A purpose has two parts, both of which are implemented through thought perception. There is the positive side – which is based on the will of God, which is the good – and there is the negative side – which is based on the destruction of the purpose of God.

Where this purpose is being implemented, only the opposite of the purpose can come together with the purpose to implement it, whether a positive or a negative side is being implemented. The opposite side of what is decided is *the mother* of the positive decision, which is *the father*. Thus both sides will be present where the implementation of this purpose is taking place, and it is the force of resistance between the two that will present what seems like a compromise, but is rather the purpose being implemented based on the conditions that it must be implemented on.

If the purpose is decided from its negative perspective, which means that the forces of good is being resisted, the resistance there is easier, because the denial of the flesh is not present, thus making the negative destructive side of a purpose weaker but more destructive.

In order for good to be promoted, bad must be demoted, and in order for evil to be chosen, good must be rejected. Every purpose is tested, and the first test drive of any purpose is implementation. Now since there is only one chance to implement, and that opportunity to implement is only once, there is no test drive, only drive.

How does the Afterlife Works – What us the Truth

What I am going to explain to you is a breakdown of step0by0step universal laws, and how they works, and walk you through and connect these truth so we can know for sure...

Purpose is what takes a person into a dream, where in this dream they forgot where the flesh body was and wonder off in the spirit body.

What cause the mind to forgot is because the flesh body has become less alert and lost its ability to concentrate. For the soul that goes into the spiritual is the same soul that was in the flesh, Therefore, its goal there in the spiritual is the same as it was in the physical.

The main thing that brings stress to the physical body is attempts that fail. Therefore, where the physical man came upon challenges in life, these challenges in the natural had set him on an escape into the spiritual world, where he ran from the physical to escape the torture, and escaped to a happier place. However, while in this more blissful place the same soul that wanted what the soul wanted still wants what the soul wanted, even though iescaped and forgot the platform of the physical flesh.

The desire of the soul to wonder after good things remains the desire of the soul to wonder after good things, whether the souk is in the natural or spiritual, for it is the same soul with the same desire. The soul itself always desire good things and will wonder after what it sees an an opportunity to achieve good things. Because the soul always wonder after its heart's bliss, the following things are true with the soul

- It can ve lost by wondering too far after those things
- It can be trained to go to the same spot times and times again, where that spot becomes a habitual spot for the soul. Where that habitual spot is outside of the will and presence of God, that soul is lost there and need deliverance,

- The soul – being lead by what it follows in it's wonder - follows the purpose of that spirit. Guilt brings self conviction, and this is a defeating battle in the spiritual, for this makes it hard for a man to rise. Know he not that whom The Son set free is free indeed?

Where the inability to forgive is taken into the spiritual, as in death, where the body of flesh and self is no longer available to deny, the state of the inability to forgive is permanent, Therefore, the person that had not forgiven his persecutors can no longer do so, neither can the mindset exist, because the state of mind that he goes into permanence with is permanent in permanence.

This is so because the spiritual world is an inheritance of the things done in the flesh, it is the best that the flesh culminates, and only that truth exists there. The flesh body and the things ad decisions in the flesh life is the only place where

sacrifices can be made. The spirit body is not for sacrifice but for the inheritance of sacrifice done in the flesh body.

Therefore the spirit body is subjected by what the flesh body had failed to overcome, and only an opportunity in the flesh body to make a better sacrifice in the denial of itself can rectify the subjectivity that the spirit body is attuned to.

If the spirit body could make the decisions that could save it then the flesh body would not be needed, but in the spirit the spirit body can neither go positive or negative without the decisions that were made by the flesh body, and how those decisions were made. .
